About ten years ago, I met a lovely couple from the East End of London. They were both in their 70s. She had advanced emphysema, she was in a wheelchair and had an oxygen tank. He was her carer – and he did everything for her – bathing, dressing, feeding. At home, he wouldn't let anyone else take on these tasks for the lady he called 'my princess'. And you know, every time he looked at her, you could see that is exactly what he saw – a princess. They had one week respite holiday each year. He told me it was great to have a break, knowing that someone else he trusted was there to help with the care. And for her part, she told me it was the only time since she had become ill, that she could enjoy time with this wonderful man, and him just be her husband.




Revitalise is the largest provider of respite holidays with nursing care for people with disabilities and carers. We don't receive any central government funding. We don't receive any lottery funding. And yet, 52 years since its conception, here we are, providing 5,000 breaks each year, and welcoming more than 1,600 volunteers to help us create a truly memorable, holiday experience for people who need 24 hour nursing care.

1 in 8 of us provide unpaid care for a loved one and just like these carers, Revitalise recognises that real care means being there 24/7 looking after not just physical but emotional needs. Just like these unsung heroes Revitalise really does care and recognises the hard work that giving and receiving care can be. As one carer said to me: "There is no way I can go off on holiday when I feel like I'm just warehousing my mum in a care home for the week. At Revitalise, I know not only that she'll be safe, but that she will feel like she's had a real holiday too".

To the guests that come through our doors and the carers who love them so much, Revitalise is a safe haven and a lifeline, but there are almost 550,000 more people in the UK who could benefit from the joy of a Revitalise break. We believe that each of these people needs - and deserves - a break.

Leaving a gift to Revitalise

Where to start with writing your Will

Revitalise understands that family and loved ones always come first and that looking after them is your priority. The first thing to do is decide what you wish to leave to them and then decide what you want to leave Revitalise. Then find a solicitor to make this happen; this can either be done over the phone or in person. At the end of this booklet are useful contacts to find your nearest solicitor and on the next page you can find wording that you can take to your solicitor to ensure your wishes are met.

Of course, making a Will sounds like a daunting task but with help from a solicitor it can be very straightforward. We strongly advise that you consult a solicitor or a legal professional when planning a Will to ensure that it's valid and that your wishes are carried out in full. Circumstances do change so we'd advise that you do review your Will from time to time to ensure that it's still valid.

Making any changes to your Will

You can simply add a codicil which bolts on to your current Will. Take your completed Codicil to your solicitor who will talk you through it.

What type of gift can I leave?

The two main types of gift

There are two main types of gift that you can leave to Revitalise, each fulfills a different purpose: a pecuniary gift which is a fixed amount of money, or a residuary gift which is the residue or part of an estate.

If you have already made a Will, you can attach a Codicil (as explained on the previous page). The below is suggested wording which you can copy out with the blanks filled in and take it along to your solicitor.



A pecuniary gift (a fixed amount of money)

I give to Revitalise, registered charity in England 295072, of 212 Business Design Centre, 52 Upper Street, London, N1 0QH, the sum of £ (pounds) or such larger sum as my executors calculate to have the same value at my death as the figure specified at the date of this (Will/Codicil), to be used for its general charitable purposes and I direct that the receipt of the treasurer or duly authorised officer shall be a sufficient discharge to my executors.



A residuary gift (the residue or part of an estate)

I give (all/fraction/% share) of the residue of my estate to Revitalise, registered charity in England 295072, of 212 Business Design Centre, 52 Upper Street, London, N1 0QH, to be used for its general charitable purposes and I direct that the receipt of the treasurer or duly authorised officer shall be a sufficient discharge to my executors.
